

Recommended Preferred Alternative

- Converting Route 28/606 cloverleaf interchange and Dulles Toll Road/Centreville Road diamond interchange to **diverging diamond configurations**
- Extending Pacific Boulevard south of Route 606 to connect with the Route 28/Innovation Avenue interchange
- Installing a two lane flyover ramp from southbound Route 28 to eastbound Dulles Toll Road
- Widening the ramp from westbound Dulles Toll Road to northbound Route 28 to two lanes and adding a ramp braid to separate traffic heading to Innovation Avenue
- Widening eastbound Dulles Toll Road to five lanes from Centreville Road to Fairfax County Parkway
- Changing the tolling rates on the Dulles Greenway and Dulles Toll Road

Study Overview

Over the past several years a number of transportation improvements have been completed in the Route 28 and Dulles Toll Road and Dulles Greenway interchange area. However, this interchange area still experiences congestion during peak travel periods and safety is still a concern. Ongoing and future planned land development in both Fairfax and Loudoun Counties is anticipated to continue increasing traffic growth.

The purpose of this study is to identify strategies to improve traffic operations and safety at the Route 28 and Dulles Toll Road and Dulles Greenway interchange area. The study analyzed roadway conditions, nearby planned and approved land development, and associated traffic growth to identify the best improvement strategies. Recommended improvements will be included in an implementation plan that will be used to guide future projects. The implementation plan will identify short-, interim-, and long-term improvement projects to address the challenges that have been identified.

At this time, no construction funding has been allocated so this study will not set construction dates. The purpose of this study is to develop proposed improvements that VDOT and other agencies can pursue for funding.
